**OPEN:** \$55 per trial. Two dog limit per handler. Wait list for third dog, separate check. Cash awards and ribbons to 5<sup>th</sup>. Lesley Love Memorial Trophy to high combined. Course: Outrun, lift, fetch, drive through two sets of panels, shed, pen, single.

**PRO-NOVICE:** \$40 per trial. Cash Awards and Ribbons to 5<sup>th</sup>. Course: Outrun, lift, fetch, drive through two sets of panels, pen.

**NURSERY:** \$42 per trial. Award to 1st. Ribbons to 3<sup>rd</sup>. Course: Outrun, lift, fetch, drive through two sets of panels, pen.

**Entries may be limited. Classes may run to a Standard.**
